Reporting Boundary:

Scope 1: Category 1 - Direct GHG emission from stationary combustor as fixed equipment, mobile source as transportation, fugitive energy direct emission as wastewater treatment, refrigerant, extinguishers, boilers and Solar Electricity panel.

Scope 2: Category 2 – Indirect emissions from purchased electricity.

Scope 3: Indirect emissions from activities by stakeholders; Category 3 – Indirect emissions from road transportation as fuel for employees travel to work, freight goods. Category 4 – indirect emissions from use of purchased materials and capital goods for production (Yarns, chemicals).

Exclusions from Reporting Boundary:

The emissions from Scope 3 including

- Category 3: Excluding types of emissions from: Transportation fuel and contractor's waste disposal and the operation of authorized stores, fabrication contractors and other representative shops
- Category 4: Emissions from the use of assets are generated through equipment leased by the reporting organization in the reporting year
- Category 5: emissions associated with end-use of sold products are result of significant evaluation of indirect GHG emission sources and no requirement from intended user.

Based on the process and procedures conducted, the GHG statement contained in the GHG Report "PAIHO 2022 GHG REPORT Ver3 update 3 May, 2023 produced by VIETNAM PAIHO LIMITED

The following improvements were raised in relation to future reporting:

- Need to learn more information about the methodology and conversion factor of greenhouse gas emissions from the solar energy system in order to increase the accuracy of the quantity results.
- Information on GHG emissions of Purchased Materials (e.g. Yarns...) which provided by Raw Material Suppliers, take a requires additional information to confirm the accuracy of the data provided.

Verification Activities:

The following were the verification activities undertaken:

- Evaluation of the monitoring and controls systems through interviewing employee's observation & inquiry
- Verification of the data through sampling recalculation, retracing, cross checking, reconciliation
- Confirmation of measuring equipment accurately described in the quantification methodology including calibration status.

The quantification and reporting of the GHG emissions has been independently verified by BSI against the specifications defined in ISO 14064-1:2018. The verification activity has been carried out in accordance with ISO 14064-3 and the principles of ISO 14065.

Responsibilities:
